The management of "Holy Crescent English Primary School", Sulthanpet, Villianur, Puducherry is hereby directed to immediately **CLOSE DOWN** the school, during this academic year 2017-18, due to non-adherence of the instructions and non-rectification of the defects by the management of the said school, stated vide previous recognition order (2016-17) cited under ref (i) above. The classrooms are still conducted in aluminium galvalum sheet roofing, with wooden board partition. Mostly two different classes are conducted combined in a single class. Adequate requisites such as drinking water, sanitary facilities, furniture and other items are found to be inadequate.

Hence, the management is instructed Not to Conduct the said school during 2017-18 and also in the ensuing academic years, without obtaining proper, prior approval from the Director of School Education.

Therefore, the management of the said school is hereby instructed to hand over all the records and registers pertaining to the school to the Inspecting Officer concerned, for further future reference as required under Rule 30(2) of the Pondicherry School Education Rules, 1996. Else, necessary action, as per the Clause 18 (5) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009, will be initiated against the said school.

The said school is still functioning in a residential building with residential occupation in the first floor of the same building. Inflammable gas cylinders are being used in these residential houses posing danger to the young students housed in the ground floor of the building. Even after repeated instructions, th management of the said school has not taken any steps for shifting the said school to a proper school building during this academic year 2017-18 also.

Hence, the management is instructed Not to Conduct the said school during 2017-18 and also in the ensuing academic years, without obtaining proper, prior approval from the Director of School Education.

The management of "Kavi Kamban English Primary School", Karayambuthur, Puducherry is hereby directed to immediately CLOSE DOWN the school, during this academic year 2017-18, due to non-adherence of the instructions and non-rectification of the defects by the management of the said school, stated vide previous recognition order (2015-16) cited under ref (i) above. The classes from Second to Seventh std., are still conducted in asbestos sheet roofed classes, the drinking water and sanitary facilities are found to be without doors, very poor condition and unhygienic, separate toilet facility for girl students are also not available. The records and registers are not maintained properly and validity of the Fire Extinguishers have been expired, posing unsafe to students in case of emergency. The basic requisites as per the RTE norms such as furniture, electrical items, library, laboratory and sports articles are found to be inadequate.

Hence, the management is instructed Not to Conduct the said school during 2017-18 and also in the ensuing academic years, without obtaining proper, prior approval from the Director of School Education.

Therefore, the management of the said school is hereby instructed to hand over all the records and registers pertaining to the school to the Inspecting Officer concerned, for further future reference as required under Rule 30(2) of the Pondicherry School Education Rules, 1996. Else, necessary action, as per the Clause 18 (5) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009, will be initiated against the said school.


