With reference cited above, sanctions were issued to the Drawing and Disbursing officers / Schools on the proposals received on Pre-Matric scholarship to OEBC students for the year 2016-17 with a request to disburse the Scholarship amount to the students through Direct Beneficiary Transfer Method. 2. In respect of the year 2016-17, the scholarships have been disbursed to the students through DBT method by the Drawing and Disbursing officers of this Directorate. Therefore all the DDOs of DD(W), CEO, and DSE are requested to furnish the Disbursement Certificate for the amount sanctioned to them for the year 2016-17. In this regard, the Joint Director of this Directorate is also requested to direct all the DDO's of Govt. Hr. Sec. School under their control to submit the disbursement certificate along with Bank Statement for the year 2016-17 and left out cases for previous year in the prescribed pro-forma enclosed to this scholarship section at the earliest.

3. Since, the above particulars are required to be furnished to the Finance Department to get the Block Expenditure Sanction for the year 2017-18, the Branch Officer and the Drawing and Disbursing officer are requested to furnish the Disbursement Certificate along with Bank Statement for the year 2016-17 and left out cases for previous year in the prescribed pro-forma enclosed at the earliest.
