**PROPOSED SCHEDULE FOR THE POST OF
PRIMARY SCHOOL TEACHER**

1. Name of the post : **Primary School Teacher**
2. Number of posts : 2165 (Two thousand one hundred and sixty five) [2017] Subject to variation dependant on work load
3. Classification : General Central Services Group 'B'
(Non-Gazetted, Non-Ministerial)
4. LEVEL in the PAY MATRIX : Level: 6
5. Whether selection post or non-selection post : Not applicable.
6. Age limit for direct recruits : Not exceeding 30 years.
(Relaxable for Government servants up to five years in accordance with orders or instructions issued by the Central Government)
Note-1: In the case of recruitment made through advertisement, the crucial date for determining the age limit shall be the closing date for receipt of applications.
Note-2: In the case of recruitment made through the Employment Exchange, the crucial date for determining the age limit shall, in each case, be the last date upto which the Employment Exchanges are asked to submit the names.
7. Educational and other qualifications required for direct recruits. : (a) Higher Secondary (or its equivalent) with at least 50% marks and 2 years Diploma in Teacher Education (by whatever name known)
(b) Pass in Central Teacher Eligibility Test
(c) Should have studied the particular Regional Language (Tamil / Telugu / Malayalam) as one of the subjects upto the Secondary level or as one of the subjects in the D.T.Ed course or studied Diploma in Teacher Education in the relevant medium of instruction.
Note-1: Relaxation upto 5% in the qualifying marks shall be allowed to the candidates belonging to reserved categories such as SC/ST/OBC/PH
Note-2: The Educational qualification for Primary School Teachers for Schools with medium of instruction in French shall be:
i) Brevet Elementaire de Francais; and
ii) Higher Secondary with at least 50% marks in aggregate; and
