The management of "Ramakrishna Vidhyalaya English Medium Middle School", Kodathur, Puducherry is hereby directed to immediately **CLOSE DOWN** the school, during this academic year 2017-18, due to non-adherence of the instructions stated vide recognition order cited under ref (i) above, by the management of the said school. Further, during the inspection of the Inspecting Officer concerned, it is observed that no students and teachers were available in the said school, the school name has been changed without prior permission of the Directorate, infrastructure facilities of the school are poor and required particulars have not been furnished by the management of the said school.

Hence, the management is instructed Not to Conduct the said school during 2017-18 and also in the ensuing academic years, without obtaining proper, prior approval of the Director of School Education.

Therefore, the management of the said school is hereby instructed to hand over all the records and registers pertaining to the school to the Inspecting Officer concerned, for further future reference as required under Rule 30(2) of the Pondicherry School Education Rules, 1996. Else, necessary action, as per the Clause 18 (5) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009, will be initiated against the said school.
