With reference cited above, sanctions were issued to the Drawing and Disbursing officers/Schools on the proposals received on revalidation orders for 2015-16/expenditure sanction for the year 2016-17 with a request to disburse the Scholarship amount to the students through **Direct Beneficiary Transfer Method**. Based on the sanctions, the Drawing and Disbursing Officers have prepared the bills and presented to DAT for payment. Further, in the sanctions issued, the Drawing and Disbursing officers of this Directorate were requested to produce **Disbursement Certificate along with Statement obtained from the Bank for the year 2016-17 for disbursement made including for the revalidation orders if issued for 2015-16 in the prescribed proforma enclosed .**

3. In respect of the year 2016-17, the attendance scholarships have been disbursed to the students through DBT method by the Drawing and Disbursing officers of this Directorate. Therefore all the DDOs under the control of the DD(W), CEO, and JD of this Directorate are requested to furnish the Disbursement Certificate for the amount sanctioned to them for the year 2016-17 at the earliest.

4. Since, the above particulars are required to be furnished to the A.G Audit during their inspection for the year 2017-18, the Branch Officers and the Drawing and Disbursing officers are requested to furnish the Disbursement Certificate along with Bank Statement for disbursement of Attendance Scholarship the year 2016-17 along with revalidation orders if issued for 2015-16 immediately.
