Sub: School Education – Closing of ‘Sharon Kids Primary School’, Kadirkamam, Puducherry – Orders issued– Reg.



The management of ‘Sharon Kids Primary School’, Kadirkamam, Puducherry is hereby directed to **CLOSE DOWN** the school during this academic year 2017-18, due to non-compliance of the remarks by the management, stated vide Memorandum cited under ref (ii) above, even after granting of sufficient time. Further, it is observed that the provisions stated in the Puducherry School Education Act (PSEA), 1987 Puducherry School Education Rules (PSER), 1996 and Puducherry Right of Children to Free and Compulsory Education Rules (RTE), 2011, have also been not adhered by the management of the school.

Hence, the management is hereby instructed to immediately issue Transfer Certificates to the students of all the classes, countersigned by the Inspecting Officer concerned and not to conduct the said school in the ensuing academic years also, without obtaining prior permission from the Directorate of School Education, Puducherry. Further, it is also instructed to hand over all the records and registers pertaining to the school to the Inspecting Officer concerned, for further future reference as required under Rule 30 (2) of the Pondicherry School Education Rules, 1996.
