Tenders in plain paper should be sealed and addressed to the Chief Educational Officer, Directorate of School Education, Puducherry duly superscribing on the envelope as "*Tender for the purchase of old condemned furniture & other items*" and sent to reach the undersigned on or before **29/10/2018** at **04.00 PM**. The tender will be opened on the same day at **04.15 P.M.** in the presence of the tenderers who are present. The rates for all the items should be quoted separately in one cover.

3. The intending tenders should deposit an amount of Rs.5,000/- (Rupees Five thousand only) as earnest money deposit. The earnest money deposit of the unsuccessful tenders will be returned immediately after tender is over.

4. Tenders received after the due date and time will be rejected.

5. The successful tenderer should pay the entire amount with GST and clear the items within 24 hours at his own risk and cost, failing which the earned money deposit will be forfeited.

6. The intending tenderers may inspect the condemned articles during School hours on any working day with prior permission of the concerned Headmasters in the above said schools without any disturbance to the students.

7. No claim on the quality and quantity of the articles will be admitted once the tender is finalised.

8. GST at the rate applicable will be charged.

9. In case of dispute, the decision of undersigned will be final.

10. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
