Please refer the Circular No. 689/SS/SBM/Swachh Pakhwada/2018-19 dated 18<sup>th</sup> June 2018. In recent communication, MHRD, New Delhi has suggested that the last day of Swachhta Pakhwada i.e. 15<sup>th</sup> Sep 2018 may be converged with the launch of "Swachhta Hi Sewa (SHS)" campaign which will go on till 2<sup>nd</sup> October 2018, throughout the country. In view of this, a slightly revised schedule of activities may be undertaken during the Pakhwada and it is given in the Annexure.

The Head of Schools may act as the Nodal Person for the activity under **"Swachhta Pakhwada" and "Swachhta Hi Sewa", 2018.**

Further, it is requested to appoint Swachhta Captain for each school and Swachhta Monitor for each class to encourage students to work for Swachhta on a sustainable basis for effective observance of Swachhta Pakhwada proactively and wholeheartedly.


